VARIANCE REQUIREMENTS

City of Knoxville Zoning Ordinance Article 7, Section 2
 The City of Knoxville Board of Zoning Appeals shall have the power and authority to grant variances from terms of this ordinance according to the procedure and under the restrictions set out in this section.
 The purpose of the variance is to modify the strict application of the specific requirements of this ordinance in the case of exceptionally irregular, narrow, shallow or steep lots, or other exceptional physical conditions, whereby such strict application would result in practical difficulty or unnecessary hardship which would deprive an owner of the reasonable use of his land. The variance shall be used only where necessary to overcome some obstacle which is preventing an owner from using his property as the zoning ordinance intended.

DESCRIPTION OF APPEAL

Describe your project and why you need variances.

CVS pharmacy wishes to update the corporate branding at this site and include the HealthHUB signs on the wall and sign panels on the existing freestanding signs. The total number of signs on the building will not change. The ordinance changed so that the total square footage of the existing signs or the new signs would not be allowed under the new code. These signs are needed because this site will be a HealthHUB location in addition to continuing as a Minute Clinic. Not all CVS pharmacy locations offer these services thus the signage is necessary to inform the general public of these offerings. To reduce the signs to a code-compliant size would result in greatly reduced visibility to the general public looking for these services.

Describe hardship conditions that apply to this variance.

The strict application of this ordinance would result in decreased motorist wayfinding as the signs would be too small to be safely read from the street. The building and existing signs pre-date the new ordinance. The ordinance is restrictive to buildings with a chamfered corner entrance.
