I. PY2020-2024 HUD Consolidated Plan

U.S. Department of Housing and Urban Development (HUD) Community Planning Development (CPD) Funds:

CDBG – Community Development Block Grant

HOME – HOME Investment Partnerships Grant

ESG – Emergency Solutions Grant

- Required by HUD every 5 years, submitted August 2020
- Involved extensive community participation
- Set High / Low Priority activities for funding
- A Strategic Plan, with no funding attached to it

2020-2024 Five Year Consolidated Plan Priorities

Reduce and Prevent Homelessness

Stabilize and Revitalize Neighborhoods

Create Economic Opportunity

Enhance the Availability, Accessibility and Quality of Affordable Housing

II. PY2023-2024 HUD Annual Action Plan

- An action plan is designed to meet the Goals and High Priority Objectives of the Five-Year Consolidated Plan
- Allows for re-evaluating changes in:
 - Community Needs
 - Opportunities and Challenges
 - Funding Sources and Amounts
- Funding is allocated annually by HUD
- Includes Consultation and Citizen Participation
- Due to HUD by May 15
- Year Four begins July 1, 2023, and ends June 30, 2024
- Annual report of accomplishments CAPER
 (PY2022-2023 CAPER is due to HUD by September 30)

HUD Funding

CDBG - Community Development Block Grant

\$1,664,584 for PY2023-2024

(2.1% decrease from current year)

Purpose: To develop viable urban communities by

- Providing decent housing
- A suitable living environment, and
- Expanding economic opportunities,

Principally for Low- and Moderate-Income (LMI)

People / Areas.

Up to 15% (\$249,687 for 2023-2024) may be used for Public Services

HUD Funding

HOME Investment Partnerships

\$1,176,996 for PY2023-2024

(1.9% decrease from current year)

Purpose: To increase homeownership and affordable housing opportunities for Low- and Very Low-Income Americans, through

- Rental Housing and
- Homeownership.

At least 15% (\$176,550 for 2023-2024) must be used for Community Housing Development Organizations (CHDOs)

HUD Funding

ESG – Emergency Solutions Grant

\$149,375 for PY2023-2024

(2% decrease from current year)

The <u>purpose</u> of ESG is to:

- Engage individuals and families living on the street;
- Improve the number and quality of emergency shelters;
- Help operate shelters and provide essential services;
- Rapidly re-house individuals and families;
- Prevent families and individuals from becoming homeless; and
- Collect and disseminate data to better coordinate resources (HMIS).

No more than 60% (\$89,625 for 2023-2024) may be used for Street Outreach and Emergency Shelter/Services

- Affordable housing and services to meet the needs of people experiencing or at-risk of experiencing homelessness
- **\$4,076,859** Allocated to the City of Knoxville (through 9/30/2030)




Knoxville Affordable Housing Fund ≥ \$5M / Year

- Launched July 2021 / \$50 M over 10 Years
- Affordable Rental Development Fund \$2.5 M (PY2022)
 - \$20.1 M since July 2017
- Affordable Housing Trust Fund/East Tennessee Foundation
 - \$9.5 M since 1993 (\$200,000 in PY2022)

Homeless General Funds \$240,000 (PY2022)

- Provides Required Match for HUD ESG
- \$1,583,617 since 2014








Beginning July 2021, the City committed \$50M over 10 years
